#### Scope:

#### Eligibility criteria:

In our college, research scholars are selected in accordance with the rules and regulations of the research wing of MGKVP (our parent university) which is through an entrance test named as 'Common Eligibility Test' (CET) for Ph.D. University also assigns research supervisors for the selected research scholars from our institution. Six seats are allotted to each Associate Professor of the college to guide the researcher while Professors are assigned to guide eight research scholars at a time. Admission criteria and fees are decided in accordance with the policies of the University.

#### Objective:

To fulfill the vision and mission of the college and its contribution in national development the 'Research Policy' of the college shall serve as an overall framework within which research activities may be carried out. The principal objectives of the Research Policy are as follows:

- To encourage a healthy research culture at the college by creating an enabling environment.
- Recognizing and advising researchers about the appropriate research opportunities announced by different academic, research, and industry or government organizations.
- To motivate and facilitate the publication of research work/project in reputed publications, academic journals with high impact factors.
- To ensure that all researchers should follow the research quality assurance framework, the research code and all applicable rules and regulations set by the University Grant commission, the State Government and Mahatma Gandhi Kashi Vidyapith research ordinance.
- All the researchers are to undertake research activities in accordance with our parent University's rules and policies.
- As our institution is affiliated to Mahatma Gandhi Kashi Vidyapith, Management of university level research activities may be coordinated by directorate of Research and Development, Mahatma Gandhi Kashi Vidyapith under the direction of the Vice-Chancellor.
